RE: Preliminary Notice to the Athlete Selection Procedure for the Olympic Games, Milan/ Cortina 2026

This note is to let Curling athletes and the community know more about where we stand with qualification for the 2026 Olympic Games.

- While we are waiting for the formal selection document template from the USOPC, we would like to share the basic principles for Olympic Selection:
 - The 2026 U.S. Olympic Team Trials for Men's and Women's Curling will take place during Q4 of 2025. Exact dates and location as well as event schedule are to be determined and posted at least 60 days in advance at USA Curling's website. The winner(s) of this event will represent Team USA at the 2026 Olympic Games.
 - Four (4) teams per gender will qualify for the Trials as follows:
 - Winner of the 2024 USA Curling Nationals, provided the team finishes 6th place or higher at the 2024 WCF World Championships.
 - Winner of the 2025 USA Curling Nationals, provided the team finishes 6th place or higher at the 2025 WCF World Championships.
 - The highest ranked team(s) via the WCF Team Rankings as of May 1, 2025, not already qualified will earn a berth.
 - If results at the 2024 and 2025 WCF World Championships do not determine Trials berths, up to two (2) berth(s) will be awarded based on WCF Team Rankings as of May 1, 2025 so potentially a max of

- three (3) teams can qualify via WCF Rankings.
 - One (1) team will qualify from a Pre-Trials Qualification event tentatively slated to be held in September of 2025. Exact date and location are to be determined and will be posted at least 60 days in advance. To be eligible to enter and compete in the Pre-Trials, teams must be ranked in the Top 100 in the WCF Team Rankings as of May 1, 2025.
 - If only one (1) US team finishes in the Top 100 of the WCF World Team Rankings as of May 1, 2025, then the Pre-Trials will be canceled, and that team would advance to the Olympic Team Trials. If no team finishes in the Top 100 then the Pre-Trials would be canceled, and no team will advance.

This note is to let Curling athletes and the community know more about where we stand with qualification for the 2026 Olympic Games.

- While we are waiting for the formal selection document template from the USOPC, we would like to share the basic principles for Olympic Selection for Mixed Doubles:
 - The 2026 U.S. Olympic Team Trials for Mixed Doubles will take place in late February/ early March 2025. Exact dates and location as well as event schedule are to be determined and posted at least 60 days in advance at USA Curling's website. The

winner(s) of this event will represent Team USA at the 2025 Mixed Doubles World Championships as well as the 2026 Olympic Games. *If Team USA is not qualified for the Olympic Games after 2025 Mixed Doubles World Championships, this team will also represent Team USA at the Olympic Qualification Event in Autumn 2025.

Ten (10) teams will qualify for the Mixed Doubles Trials as follows:

- Three (3) Teams- Top- 3 finishing teams from the 2024 Nationals
- Four (4) Teams- Pre- Trials to be held in August of 2024
- Two (2) Teams- Highest unqualified finishers of two (2) Qualifying events in the fall of 2024
- One (1) Team- Top points earner as of Jan. 14, 2025, per Mixed Doubles Ranking, year-to-date
**all locations and dates to be communicated, at the very least, 60 days prior to the start of the event but will be confirmed and communicated ASAP*

Pre Trials Qualification-

-no cap on field size as long as at least one of the following criteria is met:

- Team must have an athlete ranked in the top 50 of the M/W World Team Rankings by May 1st, 2024
- Team must be ranked in the top 75 of the WCF MD Team Ranking by May 1st, 2024 (year to date)
- Team finished in the top half of the 2024 MD US Nationals
 - If we don't have a minimum of 8 teams, we will fill those slots to meet that minimal threshold using MD Rankings as of May 1, 2024
